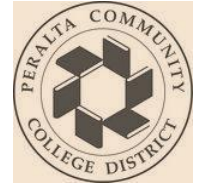

In consideration of participating in the **College of Alameda YOUTH SPORTS/FITNESS CAMPS/CLINICS/GAMES**, I represent that I understand the nature of this sport and that my son/daughter is in good health, and in proper physical condition to participate in such sport. I acknowledge that if I believe the volleyball clinics conditions are unsafe, I will immediately discontinue participation in the volleyball camps/clinics.

I hereby release, discharge, and covenant not to sue the Peralta Community College District and the College of Alameda’s faculty, staff, sponsors, volunteers and other participants (each considered one of the RELEASEES herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any loss, liability, damage, or cost, if any, which may incur as the result of such claim.

I hereby acknowledge that participation in sports/fitness, may result in accidents and/or injuries and even death. Even though I know there are risks involved in playing sports/fitness, I hereby certify that I give permission for my son/daughter to participate and I authorize the faculty and staff of the College of Alameda to act for me according to their best judgment in any emergency situation requiring medical attention if I am not present.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, and understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it be a complete and unconditional release of liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
